BROADCAST APPLICATIONS DISMISSED FOR FAILURE TO PARTICIPATE IN SUPPLEMENTAL CLOSED BROADCAST AUCTION (AUCTION NO. 28)

On December 23, 1999, the Mass Media Bureau and Wireless Telecommunications Bureau (Bureaus) issued a *Public Notice*, DA 99-2958 (December 23rd *Public Notice*), announcing the filing requirements for the Supplemental Closed Broadcast Auction scheduled to begin on March 21, 2000 (Auction No. 28). The December 23rd *Public Notice* also included a list of those applications for new AM radio, FM radio, full power television, TV Translator and Low Power Television facilities that would be included in the March 21, 2000 auction. Pursuant to the December 23rd *Public Notice*, those applicants that did not settle with the other applicants in their mutually exclusive application groups and that intended to participate in the auction were required to submit an FCC Form 175 by 5:30 PM ET on February 18, 2000. *See also* 47 C.F.R. § 73.5002(b) and Implementation of Section 309(j) of the Communications Act – Competitive Bidding for Commercial Broadcast and Instructional Television Fixed Service Licenses, *First Report and Order*, MM Docket No. 97-234, 13 FCC Rcd 15920 (1998). The December 23rd *Public Notice* stated that those applicants that did not submit an FCC Form 175 by the February 18, 2000 deadline would have their long form applications (FCC Form 301 or 346) dismissed.

The Commission did not receive an FCC Form 175 for the following long form applications (or a separate request to dismiss the long form application or settlement) and these applications are therefore dismissed:
