# TXU COMMUNICATIONS TELECOM SERVICES COMPANY AND FORT BEND LONG DISTANCE COMPANY SEEK FCC CONSENT FOR TRANSFER OF CONTROL TO TXU COMMUNICATIONS VENTURES COMPANY

### **PLEADING CYCLE ESTABLISHED**

TXU Communications Telecom Services Company (TCTSC), a wholly-owned subsidiary of TXU Energy Industries Company, and Fort Bend Long Distance Company (FBLD), which through Fort Bend Communications Company is a wholly-owned subsidiary of TXU Energy Industries Company, filed applications pursuant to Section 214 of the Communications Act, 47 U.S.C. § 214, to request Commission approval to transfer control of domestic and international authorizations held by both TCTSC and FBLD to TXU Communications Ventures Company (TCVC). The transfers would occur by making TCTSC and FBLD wholly-owned subsidiaries of TCVC, which would in turn be wholly owned by Pinnacle One Partners, L.P. TXU Communications (a wholly-owned subsidiary of TXU Energy Industries Company) and Zenith Telecom Trust (a special purpose business trust created under the laws of the state of Delaware) would each own half of Pinnacle One GP, the sole general partner of the proposed Pinnacle One Partners entity. On June 26, 2000, the applicants supplemented their applications by identifying the investors of Zenith Telecom Trust.<sup>1</sup>
