By the Accounting Policy Division, Common Carrier Bureau:

The Commission's rules provide that the Common Carrier Bureau (Bureau) must issue a decision resolving a request for review of matters properly before it within ninety days unless the time period is extended.³ The Bureau requires additional time to review the issues presented.
