## **REPORT AND ORDER** (Proceeding Terminated)

Adopted: August 8, 2000; Released: August 18, 2000

By the Chief, Allocations Branch:

1. The Allocations Branch has before it a *Notice of Proposed Rule Making*, 13 FCC Rcd 852 (1998), issued at the request of Citicasters Co. ("petitioner") proposing the allotment of Channels 228C1, 243C1 and 263C1 at Casper, Wyoming, as the community's eighth, ninth, and tenth local commercial FM transmission services (RM-9859). Petitioner filed comments in support of the proposal reaffirming its intention to apply for the respective channels, if allotted. Comments and a counterproposal were filed by Mountain States Radio, Inc. ("Mountain States") proposing the allotment of Channel 228C1 at Guernsey, Wyoming, Channel 242C at Lusk, Wyoming, and Channel 262C at Sinclair, Wyoming, as each community's first local aural transmission service (RM-9886).<sup>2</sup> Reply comments were filed by petitioner and Mount Rushmore Broadcasting, Inc. ("Mount Rushmore"). <sup>3</sup>

We note that in MM Docket No. 98-151, Channel 281A was allotted to Guernsey, Wyoming, as the community's first local aural transmission service. See Douglas and Guernsey, Wyoming, 15 FCC Rcd 9177 (2000); 65 FR 36374, June 8, 2000.

<sup>&</sup>lt;sup>2</sup> The counterproposal was placed on Public Notice on May 31, 2000 (Report No. 2114), RM-9886. We note that the request for Channel 228C1 at Guernsey, Wyoming was inadvertently placed on Public Notice. Counterproposals are required to be "technically correct and substantially complete" at the time they are filed. See e.g., Fort Bragg, California, 6 FCC Rcd 5817 (1991); Provincetown, et al., Massachusetts, 8 FCC Rcd 19 (1992); and Sanford and Robbins, North Carolina, 12 FCC Rcd 1 (1997). Specifically, Mountain States' requested site (42-24-44 NL and 104-50-13 WL) for Channel 228C1 at Guernsey, Wyoming, is short-spaced to the vacant allotment site for Channel 228A at Pine Ridge, South Dakota, and to the allotment reference coordinates for Channel 281A at Guernsey, Wyoming. As a result of the technical deficiencies inherent in the Guernsey counterproposal, it is rejected. Therefore, only the requests for Channel 242C at Lusk, Wyoming, and Channel 262C at Sinclair, Wyoming will be considered.

Such a proposal is not appropriately filed in an adjudicatory proceeding such as this and will not be considered further. In the alternative, Mount Rushmore proposes the allotment of Channel 228A at Lusk and Elk Mountain, Wyoming, Channel 243A to Medicine Bow and Manville, Wyoming, and the Channel 263A at Encampment, Wyoming and Channel 263C1 at Fort Washakie, Wyoming, As stated in the Notice, (continued....)

- 2. In support of its counterproposal proposal, Mountain States states that Lusk is an incorporated community with a 1990 U.S. Census population of 1,504 persons. It is the county seat of Niobrara County (population 2,499) and is also listed in the 1998 Rand McNally Road Atlas. Mountain States also states that Sinclair is an incorporated community and listed in the 1990 U.S. Census with a population of 500. It is also listed the 1998 Rand McNally Road Atlas. Sinclair is located in Carvin County (population 16,659). Mountain States further states that the proposed allotment at Lusk and Sinclair, Wyoming, would provide each community the its first local aural transmission service consistent with priority (3) of the FM allotment priorities set forth in Revision of FM Assignment Policies and Procedures, 90 FCC 2d 88 (1982). Mountain States affirms that it will apply for the respective channels, if allotted.
- 3. As an initial matter, we find that Lusk and Sinclair are "communities" for allotment purposes.<sup>5</sup> Conflicting proposals are considered on a comparative basis with the allotment priorities set forth in the Revision of FM Assignment Policies and Procedures, supra, serving as a guide. Our staff search reveals that there are no alternate channels for any of the communities involved. The allotment of three Class C1 channels would provide Casper with its 17th local aural transmission service, triggering priority (4)-other public interest matters, whereas the allotment of Class C channels at Lusk and Sinclair would provide each community with its first local aural transmission, triggering priority (3). Therefore, we find that the public interest would best be served by allotting Channel 228C1 at Casper, Wyoming, Channel 242C at Lusk, Wyoming, and Channel 262C at Sinclair, Wyoming.

## **Technical Summary**

4. An engineering analysis has determined that Channel 228C1 can be allotted at Casper in compliance with the Commission's minimum distance separation requirements with a site restriction of 7.9 kilometers (2.2 miles) southeast to avoid a short-spacing to the allotment reference site for Channel 228A at Moorcroft, Wyoming. Additionally, Channel 242C an be allotted to Lusk in compliance with the Commission's minimum distance separation requirements at city reference coordinates; and Channel 262C can be allotted to Sinclair with a site restriction of 8 kilometers (5 miles) north at petitioner's requested site.

307(b) of the Communications Act of 1934, as amended, and Sections 0.61. 0.204(b) and 0.283 of the Commission's Rules, IT IS ORDERED, That effective October 2, 2000, the FM Table of Allotments, Section 73.202(b) of the Commission's Rules, IS AMENDED, with respect to the communities listed below, as follows:

Casper, Wyoming 228C1, 233C, 238C, 247C1

273C, 279C, 284C1, 295C

Lusk, Wyoming 242C

Sinclair, Wyoming 262C

6. Filing windows for Channel 228C1 at Channel 228C1 at Casper, Wyoming, Channel 242C at Lusk, Wyoming, and Channel 262C at Sinclair, Wyoming, will not be opened at this time. Instead, the issue of opening filing windows for these channels will be addressed by the Commission in a subsequent order.
