CITIZENS TELECOMMUNICATIONS COMPANY OF WYOMING AND QWEST CORPORATION SEEK A WAIVER OF THE DEFINITION OF "STUDY AREA" IN PART 36 OF THE COMMISSION'S RULES

On August 21, 2000, Citizens Telecommunications Company of Wyoming (Citizens) and Qwest Corporation (Qwest) filed a joint petition for waiver of the definition of "study area" as set forth in Part 36 of the Commission's rules. That definition constitutes a rule freezing all study area boundaries. Citizens is acquiring from Qwest five telephone exchanges serving approximately 6,000 access lines in Wyoming, including 34 access lines physically located in Idaho. By this waiver, Qwest seeks to alter its Wyoming study area in order to remove these telephone exchanges being transferred to Citizens. Citizens seeks a waiver of the study area freeze to establish a Wyoming study area consisting of the telephone exchanges it is acquiring from Qwest. The petitioners submitted letters from the Public Service Commission of Wyoming and the Idaho Public Utilities Commission indicating that they have no objection to the issuance of a study area waiver associated with Citizens' acquisition of the five telephone exchanges.

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on or before **September 13, 2000**, and reply comments on or before **September 25, 2000**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 Fed. Reg. 24,121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to http://www.fcc.gov/e-file/ecfs.html. Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of this proceeding, however, commenters must transmit one electronic copy of the transmittal screen, commenters should include their full name, Postal Service mailing address, and the applicable docket or rulemaking number.
