## **ORDER**

By the Acting Chief, Financial Analysis and Compliance Division, Cable Services Bureau:

- 1. In this Order we consider the refund plan filed by the above-referenced operator ("Operator") in the above-referenced communities pursuant to our Order, DA 98-2130<sup>1</sup> ("Refund Order").<sup>2</sup> Our review of Operator's refund plan reveals that the refund plan fulfills the requirements of the Refund Order.<sup>3</sup>
