## COMMON CARRIER BUREAU RELEASES REVISED LIST OF CARRIERS FILING RURAL CERTIFICATION LETTERS AND NOTIFICATIONS OF CHANGES IN STATUS

## CC Docket No. 96-45

On October 21, 1999, the Commission required rural carriers serving study areas with more than 100,000 access lines to file certification letters by July 1, 2000. The Commission required such carriers to explain how they meet the criteria set forth in the definition of "rural telephone company" in section 153(37) of the Communications Act, as amended. Specifically, the Commission required a carrier self-certifying as a rural telephone company as defined in section 153(37)(A) to include a description of the study areas in which it provides service and the basis for its assertion that it meets the requirements of this subsection. Similarly, the Commission required a carrier self-certifying as a rural telephone company as defined in section 153(37)(D) to include a list of all communities to which it provides service, the population of those communities, the number of its access lines serving those communities, and the total

Section 153(37)(C) provides that a local exchange carrier operating entity is deemed a rural telephone company to the extent that such entity "provides telephone exchange service to any local exchange carrier study area with fewer than 100,000 access lines. Thus, a carrier serving study areas with more than 100,000 access lines could not, by definition, meet the criteria set forth in section 153(37)(B) or (C). number of access lines it serves.<sup>4</sup> In subsequent years, carriers serving study areas with more than 100,000 access lines need only file certification letters if their status changes.<sup>5</sup>

On August 1, 2000, the Common Carrier Bureau released a list of carriers filing rural certification letters, which inadvertently omitted Citizens Telecommunications of California.<sup>6</sup> The following revised list indicates those carriers filing rural certification letters stating they meet the criteria in section 153(37)(D):<sup>7</sup>

In addition, GTE Northwest – Washington (Contel), filed a letter notifying the Commission that it now has more than 100,000 access lines and its status has changed from a rural telephone company to a non-rural company. We also note that ALLTEL did not file a rural certification letter for ALLTEL Ohio, so we anticipate that ALLTEL Ohio will be treated as a non-rural company for federal universal service purposes beginning in the year 2001.

These certification and notification letters have been filed with the Secretary and placed on the record in CC Docket No. 96-45.
