THE WIRELESS TELECOMMUNICATIONS BUREAU ANNOUNCES THE GRANT OF NINE LICENSES TO OPERATE IN THE 39 GHZ BAND

Auction No. 30

On August 16, 2000, the Wireless Telecommunications Bureau announced that it was prepared to grant the long-form applications (FCC Form 601) for authority to operate in the 38.6-40.0 GHz (39 GHz) band that were filed by Pinpoint Wireless, Inc., and Morgan Stanley Capital Group, Inc., provided that they submit a final payment on their licenses by either the initial or late payment deadline.¹ The late payment deadline of September 14, 2000, was met by both applicants. Accordingly, on September 19, 2000, we granted the nine licenses listed in the Attachment. We granted these licenses pursuant to Section 309(a) of the Communications Act of 1934, as amended,² and Section 0.331 of the Commission's Rules³ because it will serve the public interest, convenience, and necessity.
