PETITION OF AMSC SUBSIDIARY CORPORATION FOR CLARIFICATION OF SECTIONS 54.601(C) AND 54.506 OF THE COMMISSION'S RULES

On November 24, 1999, AMSC Subsidiary Corporation (AMSC) filed a petition requesting the Commission to clarify two of its rules applicable to Universal Service Fund (USF) support for rural health care providers. AMSC states that it is now in a position to offer critical emergency communications services to Indians throughout the United States, without the need to construct and deploy costly wireline infrastructure. To initiate the process of offering these emergency services, AMSC requests that the Commission either issue in the pending proceeding relating to the unserved and tribal areas² a preliminary order that the rural health care support mechanism will support the leasing of AMSC's Mobile Satellite Service (MSS) terminals, or waive the rules currently precluding such support. AMSC also seeks clarification of section 54.506 of the Commission's rules regarding the determination of the "urban rate" for purposes of calculating the discount applicable to the provision of emergency communications services on tribal lands.

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on or before **February 23, 2000**, and reply comments on or before **March 6, 2000**.
