# VISTA-UNITED TELECOMMUNICATIONS SEEKS FCC CONSENT TO TRANSFER CONTROL TO SMART CITY TELECOMMUNICATIONS

### PLEADING CYCLE ESTABLISHED

Vista-United Telecommunications ("Vista-United") and Smart City Telecommunications LLC ("Smart City") have filed an application pursuant to section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, requesting Commission approval to transfer control of domestic section 214 authorization held by Vista-United to Smart City. Vista-United is authorized to provide domestic telecommunications services pursuant to blanket section 214 authority. The requested transfer of control is part of an agreement with Smart City and its parent, Smart City Holdings LLC, and Vista-United, a Florida general partnership, and its general partners, Vista Communications, Inc. and United Telephone of Florida, whereby Smart City will operate certain telecommunications business activities currently engaged in by Vista-United.
