On December 30, 1999, the National Exchange Carrier Association, Inc. (NECA) filed a letter with the Commission signed by Particia A. Chirico, Executive Director, Tariff, Rates, Costs & Average Schedules, certifying that the directors of NECA believe that no revisions to the average schedule formulas are warranted for the upcoming annual period. According to the letter, "[i]n its 1999 Study, NECA developed a set of average schedule formulas reflecting current cost and demand trends. Although the formulas derived from these data showed both positive and negative changes among individual formulas, the overall effects of revising the formulas would be *de minimis*, (in this instance, less than a 1% change)." Based on these results, NECA determined not to propose revisions to the average schedule formulas and, thus, proposes to retain the current formulas for the upcoming annual period, July 1, 2000 through June 30, 2001.
