EAGLENET, INC., PANHANDLE TELEPHONE COOPERATIVE, INC., AND PIONEER TELEPHONE COOPERATIVE, INC. SEEK WAIVER OF THE DEFINITION OF "STUDY AREA" IN PART 36 OF THE COMMISSION'S RULES

On January 24, 2000, EagleNet, Inc. (EagleNet), Panhandle Telephone Cooperative, Inc., Panhandle Telephone Cooperative, Inc., and Pioneer Telephone Cooperative, Inc. (Pioneer), filed a joint petition for waiver of the definition of "study area" as set forth in Part 36 of the Commission's rules.¹ That definition constitutes a rule freezing all study area boundaries.

On February 18, 1994, the Commission waived several of its rules to effectuate the proposed sale to EagleNet of 14 rural GTE telephone exchanges in Oklahoma.² EagleNet and Pioneer entered into an agreement for the subsequent sale of the assets associated with six of those telephone exchanges, which were contiguous with the Pioneer telephone exchanges. The six subject telephone exchanges were transferred from EagleNet to Pioneer, which has since operated the telephone exchanges independently, but within the parameters of the EagleNet study area.

Petitioners seek to segregate the Pioneer telephone exchanges and associate these telephone exchanges with the existing Pioneer study area. Petitioners contend that this waiver is sought to regularize reporting and accounting practices, and to respond in a reasonable and orderly manner to

the notification from the National Exchange Carrier Association, Inc. that it will no longer accept petitioners' prior practice of conducting separate studies for each of the EagleNet and Pioneer study areas for consolidation at the Part 69 reporting level. Further, petitioners state that grant of the requested waiver will enable them to complete the process of independent operation of the subject exchanges.

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on or before March 21, 2000, and reply comments on or before March 31, 2000. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. See Electronic Filing of Documents in Rulemaking Proceedings, 63 Fed.
