COMMERCIAL WIRELESS DIVISION OF THE WIRELESS TELECOMMUNICATIONS BUREAU ANNOUNCES IT IS PREPARED TO GRANT TWO F BLOCK PCS LICENSES

Auction No. 11

On February 19, 1997, the Commercial Wireless Division (Division) of the Wireless Telecommunications Bureau accepted for filing the FCC long form (Form 600) applications for Basic Trading Area (BTA) licenses on the F block in the 2 GHz band for Broadband Personal Communications Services (PCS) for the following applicants:¹

Totot Communications, Inc., (Totot) Market B490F, Guam, File No. 00183-CW-L-97

Saipan Communications, Inc., (Saipan) Market B493F, Northern Marianas, File No. 00186-CW-L-97

After reviewing the applications, filed by Saipan and Toto, the Division announces that it is prepared to grant the long form applications, upon the timely payment of the remaining five (5) percent down payment due on the F block licenses. Such payment must be received by the Commission within ten (10) business days of the date of this Public Notice (*i.e.*, by **March 21, 2000**). If the applicants fail to pay the remaining down payment by the **March 21, 2000** deadline, the applicants will be allowed to make payment within ten (10) business days (*i.e.* **April 4, 2000**) after the payment deadline provided that it also pays a late fee equal to five percent of the amount due. See 47 C.F.R. § 1.2109(a).

In addition to the payment, the applicants must also inform the Commission if they wish to participate in the Commission's installment payment plan. If the applicants elect to participate in the installment payment plan and timely notifies the Commission, a Note, Security Agreement, and financing statements (*i.e.*, the UCC-1 Forms) and other related documentation commemorating the installment payment obligations, and the Commission's security interest in the licenses, will be sent to the applicants. They must then execute and return these documents to the Commission within ten (10) business days from the date of receipt of the documents. The applicants are responsible for payment of all costs associated with the preparation and recordation of the financing statements.

In the event that an applicant elects not to participate in the Commission's installment payment plan, the applicants must make full payment of all monies due for the licenses within ten (10) business days of the issuance of this Public Notice (*i.e.*, by **March 21, 2000**) or full payment along with a late fee equal to five percent of the amount due by the late payment deadline of **April 4, 2000**.

If an applicant fails to pay at least the second down payment by the late payment deadline of **April 4, 2000**, it will be considered in default on its licenses and subject to the applicable default payments. See 47 C.F.R. § 1.2109(a).

Payment Instructions

All payments must be in U.S. dollars and made in the form of a wire transfer. No personal checks, credit card payments, or other forms of payment will be accepted.

Wire transfer payments must be received by Mellon Bank by 6:00 p.m. Eastern Time on **March 21, 2000** and no later than 6:00 p.m. Eastern Time on the late payment deadline of **April 4, 2000**, along with the five percent late payment fee. Sufficient time should be allowed for the wire transfer to be initiated and for the transmission to be completed prior to the deadline. To submit funds by wire, the following information is required to properly effect the transmittal:

Payments must be accompanied by a completed FCC Remittance Advice Form (FCC Form 159). On the same business day that the applicant pays the five percent down payment due to Mellon Bank, the applicant must fax a completed FCC Form 159 to Mellon Bank at (412) 236-5702 at least one hour prior to placing the order for the wire transfer. On the FCC Form 159, the applicant must use the same FCC Taxpayer Identification Number (TIN) used on their long-form applications.
