By the Chief, Allocations Branch:

- In response to a petition filed by Leon Hunt d/b/a Hunt Broadcasting ("Hunt"), Commission has before it for consideration the Notice of Proposed Rule Making, 14 FCC Rcd 9549 (1999), seeking the allotment of Channel 267A at Madisonville, Texas, as that community's third FM broadcast service. Hunt filed supporting comments in which it reaffirmed its support in the allotment of Channel 267A at Madisonville. No other comments were received in response to the Notice for Madisonville.
- We believe that the public interest would be served by the allotment of Channel 267A at Madisonville, Texas, as it will provide the community with additional broadcast service. Channel 267A can be allotted to Madisonville in compliance with the Commission's minimum distance separation requirements with a site restriction 8.09 kilometers (5.0 miles) north of the community.²
- Accordingly, pursuant to the authority contained in Sections 4(i), 5(c)(1), 303(g) and (r) and 307(b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204(b) and 0.283 of the Commission's Rules, IT IS ORDERED, That effective May 30, 2000, the FM Table of Allotments, Section 73.202(b) of the Commission's Rules, IS AMENDED for the community listed below, as follows:
