WIRELESS TELECOMMUNICATIONS BUREAU SEEKS COMMENT ON VODAFONE AIRTOUCH PLC, BELL ATLANTIC CORPORATION, AND GTE CORPORATION REQUEST FOR TEMPORARY WAIVER OF SECTION 20.6 OF THE COMMISSION'S RULES

PLEADING CYCLE ESTABLISHED

Comments/Petitions due: May 9, 2000 Responses/Oppositions due: May 16, 2000

On April 6, 2000, Vodafone AirTouch Plc ("Vodafone"), Bell Atlantic Corporation ("Bell Atlantic"), and GTE Corporation ("GTE") (collectively, "the Applicants") filed a Petition for Temporary Waiver of CMRS Spectrum Cap Rule, codified in section 20.6 of the Commission's rules. ¹

The Applicants seek a waiver of the spectrum cap rule for a temporary period not to exceed 90 days following consummation of the Bell Atlantic/GTE merger, approval of which is pending before the Commission. The Applicants contend that the temporary waiver would enable them to undertake the required divestitures of wireless businesses in a more orderly and efficient manner and in conformance with the terms of the consent decree between the parties and the Department of Justice, which was recently entered by the U.S. District Court for the District of Columbia. The requested waiver is limited to CMRS licenses listed in Attachment 1.

Interested parties may file comments on the Applicants' Petition for Temporary Waiver of CMRS Spectrum Cap Rule on or before **May 9, 2000**.
