**NOTICE OF PROPOSED RULE MAKING**

**Adopted: May 16, 2001**

**Released: May 25, 2001**

1. The Commission has before it for consideration a Petition for Rule Making filed by Jeffrey A. Bruton (“Bruton”), requesting the allotment of Channel 272A at Waitsburg, Washington, as the community’s first local service. Bruton has stated that he will file an application to operate an FM station at Waitsburg if Channel 272A is allotted to the community.

2. We believe the proposal warrants consideration because the proposed allotment would provide a first local service to the community of Waitsburg, Washington. In support of his proposal, Bruton states that an allotment at Waitsburg is in the public interest and has provided an engineering report showing that the allotment meets the spacing requirements of Section 73.207 of the Commission’s Rules. According to Bruton, the community of Waitsburg, located in Walla Walla County, is listed in the 1990 U.S. Census with a population of 990 people. A staff engineering analysis indicates that Channel 272A can be allotted to Waitsburg, Washington, consistent with the minimum distance separation requirements of the Commission’s Rules provided there is a site restriction 12.8 kilometers (7.9 miles) east of the community.<sup>1</sup> The site restriction will prevent a conflict with Station KZZM, Channel 270C2, Weston, Oregon and Station KORD, Channel 274C, Richland, Washington. Since the community of Waitsburg is located within 320 kilometers of the U.S.-Canadian border, concurrence of the Canadian Government will be requested for this allotment.

3. In view of the fact that the proposed allotment could provide Waitsburg with its first local

service, the Commission believes it would serve the public interest to solicit comments on the proposal to allot Channel 272A to Waitsburg, Washington. Therefore, we will seek comments on the proposed amendment to the FM Table of Allotments, Section 73.202(b) of the Commission's Rules, with respect to Waitsburg, Washington:

The Commission's authority to institute rule making proceedings, showings required, cut-off procedures, and filing requirements are contained in the attached Appendix and are incorporated by reference herein. In particular, we note that a showing of continuing interest is required by paragraph 2 of the Appendix before a channel will be allotted.

5. Interested parties may file comments on or before July 16, 2001, and reply comments on or before July 31, 2001, and are advised to read the Appendix for the proper procedures. For purposes of this restricted notice and comment rule making proceeding, members of the public are advised that no ex parte presentations are permitted from the time the Commission adopts a Notice of Proposed Rule Making until the proceeding has been decided and such decision is no longer subject to reconsideration by the commission or review by any court. An ex parte presentation is not prohibited if specifically requested by the Commission or staff for the clarification or adduction of evidence or resolution of issues in the proceeding. However, any new written information elicited from such a request or a summary of any new oral information shall be served by the person making the presentation upon other parties to the proceeding unless the Commission specifically waives this service requirement. Any comment which has not been served on the petitioner constitutes an ex parte presentation and shall not be

considered in the proceeding. Any reply comment which has not been served on the person(s) who

filed the comment, to which the reply is directed, constitutes an ex parte presentation and shall not be considered in this proceeding.

**APPENDIX**

1. Pursuant to authority found in Sections 4(i), 5(c)(1), 303(g) and (r) and 307(b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204.(b) and 0.283 of the Commission's Rules, **IT IS PROPOSED TO AMEND** the FM Table of Allotments, Section 73.202(b) of the Commission's Rules and Regulations, as set forth in the Notice of Proposed Rule Making to which this Appendix is attached.

2. Showings Required. Comments are invited on the proposal(s) discussed in the Notice of Proposed Rule Making to which this Appendix is attached. Proponent(s) will be expected to answer whatever questions are presented in initial comments. The proponent of a proposed allotment is also expected to file comments even if it only resubmits or incorporates by reference its former pleadings. It should also restate its present intention to apply for the channel if it is allotted and, if authorized, to build a station promptly. Failure to file may lead to denial of the request.

3. Cut-off Procedures. The following procedures will govern the consideration of filings in this proceeding.

(a) Counterproposals advanced in this proceeding itself will be considered if advanced in initial comments, so that parties may comment on them in reply comments. They will not be considered if advanced in reply comments. (See Section 1.420(d) of the Commission's Rules).

(b) With respect to petitions for rule making which conflict with the proposal(s) in this Notice, they will be considered as comments in the proceeding, and Public Notice to this effect will be given as long as they are filed before the date for filing initial comments herein. If they are filed later than that, they will not be considered in connection with the decision in this docket.

(c) The filing of a counterproposal may lead the Commission to allot a different channel than was requested for any of the communities involved.

4. Comments and Reply Comments; Service. Pursuant to applicable procedures set out in Sections 1.415 and 1.420 of the Commission's Rules and Regulations, interested parties may file comments and reply comments on or before the dates set forth in the Notice of Proposed Rule Making to which this Appendix is attached. All submissions by parties to this proceeding or by persons acting on behalf of such parties, must be made in written comments reply comments, or other appropriate pleadings. Comments shall be served on the petitioner by the person filing the comments. Reply comments shall be served on the person(s) who filed comments to which the reply is directed. such comments and reply comments shall be accompanied by a certificate of service. (See Section 1.420(a), (b) and (c) of the Commission's Rules.) Comments should be filed with the Secretary, Federal communications Commission, Washington, D, C. 20554.

5. Number of Copies. In accordance with the provisions of Section 1.420 of the Commission's Rules and Regulations, an original and four copies of all comments, reply comments, pleadings, briefs, or other documents shall be furnished the Commission.

6. Public Inspection of Filings. All filings made in this proceeding will be available for examination by interested parties during regular business hours in the Commission's Public Reference Room at its headquarters, 445 Twelfth Street, SW, Washington, D. C 20554.
