COMMENTS SOUGHT ON SBC ADVANCED SOLUTIONS, INC. PETITION FOR INTERIM WAIVER OF SECTIONS 61.58, 61.38 AND 61.59 OF THE COMMISSION'S RULES

On October 3, 2001, SBC Advanced Solutions, Inc. (SBC-ASI) petitioned the Commission for an expedited ruling that it is non-dominant in its provision of advanced services, and for forbearance from dominant carrier regulation of those services. For an interim period until the Commission issues a decision, SBC-ASI separately petitioned the Common Carrier Bureau on November 2, 2001 for waiver of: (a) Section 61.58, so that it may file tariff modifications on not less than one day's notice; (b) Section 61.38, so that it may file tariff modifications without cost support; and (c) Section 61.59, so that it may make changes to prices and regulations that have not been in effect for 30 days.

Interested parties may file comments no later than **December 28, 2001**. Reply comments may be filed no later than **January 14, 2002**. When filing comments, please reference **CCB/CPD File No. 01-25**. An original and four copies of all comments and reply comments must be filed with the Office of the Secretary, Federal Communications Commission, 445 12th Street, S.W., Room TW-B204, Washington, D.C. 20554. This proceeding shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. *See* 47 C.F.R. §§ 1.1200 and 1.1206. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented is generally required. *See* 47 C.F.R. § 1.1206(b). Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules, 47 C.F.R. § 1.1206(b).
