## **ORDER**

By the Accounting Policy Division, Common Carrier Bureau:

1. This Order dismisses the Request for Review filed by Blessed Sacrament - St. Gabriel High School (Blessed Sacrament), New Rochelle, New York.<sup>1</sup> Blessed Sacrament seeks review of a decision issued by the Schools and Libraries Division (SLD) of the Universal Service Administrative Company (Administrator) on August 21, 2001.<sup>2</sup> The Commission received Blessed Sacrament's Request for Review on September 27, 2001.<sup>3</sup> Under section 54.720(b) of the Commission's rules, any such appeal must be filed with the Commission or SLD within 30 days of the issuance of the decision that the party seeks to have reviewed.<sup>4</sup> Documents are considered to be filed with the Commission only upon receipt.<sup>5</sup> Because the instant Request for Review was not filed within the specified 30-day period, it must be dismissed without further consideration.
