**ECHOSTAR COMMUNICATIONS CORPORATION, GENERAL MOTORS CORPORATION,  
AND HUGHES ELECTRONICS CORPORATION SEEK FCC CONSENT  
FOR A PROPOSED TRANSFER OF CONTROL  
CS DOCKET NO. 01-348**

**Petitions/Comments due: February 4, 2002**

**Oppositions/Responses due: February 25, 2002**

On December 3, 2001, the Commission received applications requesting consent to the transfer of control of licenses and authorizations held by Hughes Electronics Corporation ("Hughes") and its subsidiaries and affiliates and by EchoStar Communications Corporation ("ECC") and its subsidiaries and affiliates (collectively, the "Applicants") to EchoStar Communications Corporation, a Delaware corporation. Hughes controls various space station, earth station, wireless and experimental licenses and Section 214 authorizations, including licenses and Section 214 authorizations held by PanAmSat Corporation ("PanAmSat") and its wholly-owned subsidiaries. ECC controls various space station and earth station licenses, including licenses and authorizations held by EchoStar Satellite Corporation, EchoStar 110 Corporation, EchoStar North America Corporation and EchoStar VisionStar Corporation.

Additionally, the Applicants request that the Commission approve the transfer of control of Section 214 authorizations controlled by Hughes to New EchoStar.

The proposed license transfers will result from the spin-off of Hughes from General Motors Corporation ("GM"), which currently owns all of the capital stock of Hughes, and the merger of ECC with and into Hughes. Hughes will be the surviving corporation, with a new ownership structure, and the merged entity will be renamed EchoStar Communications Corporation ("New EchoStar"). The proposed transaction includes the transfer of Hughes' indirect majority equity stake in PanAmSat, either to New EchoStar through the merger, or in the event the merger agreement is terminated under certain specified circumstances to ECC through a separate purchase of Hughes' interest in PanAmSat.

On December 18, 2001, the Applicants submitted a letter advising the Commission that on December 14, 2001, ECC signed definitive agreements relating to a transaction with Vivendi Universal S.A. (“Vivendi”) that will, among other things, result in certain minor changes to ECC’s ownership structure and composition of its Board of Directors. In addition, as part of the transaction, ECC has agreed to carry five new Vivendi channels, to make available the equivalent of about eight video channels on its system for new interactive services, to deploy certain “middleware” technology on some set-top boxes, and to carry Vivendi films and music on a pay-per-view basis. The Applicants indicate that they will amend their application to reflect the changes in ownership structure and composition of the Board of Directors following the closing of ECC’s transaction with Vivendi. The Commission is reviewing the letter and will inform the Applicants when it determines what additional information and/or amendments to the applications may be appropriate in light of the arrangement it describes.

ECC and Hughes, through its DirecTV subsidiary, are the two major direct broadcast satellite (“DBS”) providers in the United States. ECC, GM, and Hughes submit that the proposed transaction will promote the public interest. They state that New EchoStar will more efficiently use spectrum to offer more local-into-local programming, provide a competitive alternative to cable television, offer more broadband services, provide better service to rural and outlying areas at nationally standardized prices, and offer more niche, educational and high-definition television programming. Further, the Applicants assert that the transaction with Vivendi will provide consumers with additional programming diversity and enhanced services.

Interested parties may file comments or petitions to deny the applications no later than **February 4, 2002**. Oppositions or responses to these comments and petitions may be filed no later than **February 25, 2002**. Given recent changes in the mail delivery process, we strongly urge commenters to use the Commission’s Electronic Comment Filing System (ECFS). Procedures for filing through ECFS are described below in the “General Information” section.

For administrative convenience, the various applications listed in the Attachment below have been consolidated into one general docket. All filings regarding any aspect of the proposed merger should reference the docket assigned to this proceeding, **CS Docket No. 01-348**.

### ***EX PARTE* STATUS OF THIS PROCEEDING**

Because this proceeding involves broad public policy issues, the proceeding will be treated as “permit but disclose” for purposes of the Commission’s *ex parte* rules. See generally 47 C.F.R. §§ 1.1200-1.1216. Should circumstances warrant, this proceeding or any related proceeding may be designated as restricted. As a “permit but disclose” proceeding, *ex parte* presentations will be governed by the procedures set forth in Section 1.1206 of the Commission’s rules applicable to non-restricted proceedings.<sup>1</sup>

Parties making oral *ex parte* presentations are directed to the Commission’s statement re-emphasizing the public’s responsibility in permit-but-disclose proceedings and are reminded that memoranda summarizing the presentation must contain the presentation’s substance and not merely list the

subjects discussed.<sup>2</sup> More than a one or two sentence description of the views and arguments presented is generally required. See 47 C.F.R. § 1.1206(b)(2), as revised. Other rules pertaining to oral and written presentations are set forth in Section 1.1206 (b) as well. We urge parties to use ECFS to file *ex parte* submissions. See “General Information” section below.

### **TRANSFER OF CONTROL APPLICATIONS**

ECC’s, GM’s, and Hughes’s consolidated application includes the Commission authorizations and licenses listed in the Attachment below. They are separated by type of authorization and license. Interested parties should refer to the transfer of control applications for a listing of the authorizations or licenses. Each of the Applicants’ subsidiaries or affiliates may hold multiple authorizations or licenses of a particular type. Parties should be aware that additional applications may have to be filed to identify any additional authorizations involved in this transaction. ECC, GM, and Hughes have requested a waiver of the Commission’s “cut-off” rule that requires an application to be newly filed if the applicant’s beneficial ownership or control structure substantially changes.<sup>3</sup> ECC, Hughes and its subsidiaries have numerous pending applications for earth and space station authorizations before the Commission and these additional authorizations, pending approval, would be included in this consolidated application.

### **GENERAL INFORMATION**

The applications for transfer of control of the licenses/authorizations referenced herein have, upon initial review, been accepted for filing. The Commission reserves the right to return any applications if, upon further examination, they are determined to be defective and not in conformance with the Commission’s rules, regulations, or policies.

Final action will not be taken on the applications earlier than 31 days following the date of this Notice. Interested parties may file pleadings as indicated above regarding the applications. Parties are encouraged to file comments using ECFS. See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 Fed. Reg. 24,121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <<http://www.fcc.gov/e-file/ecfs.html>>. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, commenters should include their full name, Postal Service mailing address, and the applicable docket or rulemaking number.
