## WIRELESS TELECOMMUNICATIONS BUREAU GRANTS CONSENT FOR THE TRANSFER OF CONTROL OF LICENSES FROM CENTURYTEL, INC. TO ALLTEL COMMUNICATIONS, INC.

WT Dkt. No. 02-85

Pursuant to sections 4(i) and 310(d) of the Communications Act of 1934, as amended,<sup>1</sup> and section 0.331 of the Commission's rules,<sup>2</sup> the Wireless Telecommunications Bureau ("Bureau") approves the applications listed below requesting Commission consent to transfer control of certain broadband Personal Communications Service ("PCS"), Fixed Microwave Service, and Cellular Radiotelephone Service licenses and authorizations currently held by CenturyTel, Inc. and certain of its affiliates ("CenturyTel") to ALLTEL Communications, Inc. ("ACI").<sup>3</sup> No comments or petitions to deny were received in response to the Public Notice announcing that the applications had been accepted for filing.<sup>4</sup> The Bureau finds, upon consideration of the record, that the proposed transfers of control will serve the public interest, convenience, and necessity.<sup>5</sup>
