By the Telecommunications Access Policy Division, Wireline Competition Bureau:

1. The Telecommunications Access Policy Division has under consideration a Request for Review filed by Lincoln School, Dumont, New Jersey (Lincoln).¹ Lincoln requests review of a decision by the Schools and Libraries Division (SLD) of the Universal Service Administrative Company (Administrator) regarding invoices filed in relation to Lincoln's request for discounts in Funding Year 1999 of the schools and libraries universal service support mechanism.² Specifically, Lincoln requests that the invoices be considered as timely filed.³ Upon our review of the record, however, we find that SLD issued an Administrator's Decision on Invoice Deadline Extension Request, approving Lincoln's request for a 60-day extension of the

Section 54.719(c) of the Commission's rules provides that any person aggrieved by an action taken by a division of the Administrator may seek review from the Commission. 47 C.F.R. § 54.719(c). In prior years, this funding period was referred to as Funding Year 2. Funding periods are now described by the year in which the funding period starts. Thus, the funding period which began on July 1, 1999 and ended on June 30, 2000, previously known as Funding Year 2, is now called Funding Year 1999. The funding period which began on July 1, 2000 and ended on June 30, 2001 is now known as Funding Year 2000, and so on.

deadline for submission of its invoice number 289253 from the date of the issuance of this decision.⁴ Therefore, we dismiss Lincoln's Request for Review as moot.

2. ACCORDINGLY, IT IS ORDERED, pursuant to authority delegated under sections 0.91, 0.291, and 54.722(a) of the Commission's rules, 47 C.F.R. §§ 0.91, 0.291, and 54.722(a), that the Request for Review filed by Lincoln School, Dumont, New Jersey, on April 17, 2002, IS DISMISSED as moot.
