MEDIA BUREAU ANNOUNCES RECEIPT OF SUPPLEMENTAL INFORMATION FROM APPLICANTS IN AT&T-COMCAST PROCEEDING; ESTABLISHES COMMENT DEADLINE

Comment Deadline: September 5, 2002

Pending before the Commission are applications (collectively, the “Application”) requesting consent to transfer to AT&T Comcast Corporation (“AT&T Comcast”), control of (1) licenses and authorizations held by Comcast Corporation (“Comcast”) and (2) licenses and authorizations held by AT&T Corp. (“AT&T”) associated with the operation of their respective cable systems.

A public notice in this proceeding adopted on August 23, 2002 and released on August 26, 2002¹ announced plans to establish a revised deadline for comment on Applicants’ proposal to insulate and divest AT&T’s interest in Time Warner Entertainment (“TWE”) following receipt of supplemental information from the Applicants concerning their planned restructuring of the TWE partnership.² On August 23, 2001, we also received the requested information from the Applicants. Specifically, the Applicants filed the August 21, 2002 agreement to restructure the partnership, which was made available to the public on the ECFS system and on the merger web pages maintained by the Media Bureau and the Office of General Counsel. Accordingly, we extend the August 30, 2002 comment deadline to ten days from the date of this Public Notice.

Pursuant to Sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on or before **September 5, 2002**. Comments should be filed in accordance with the procedures described in our August 9, 2002 Public Notice in this proceeding.³
