WAYNE M. PERRY, DON A. ADAMS, AND DARLA POMEROY SEEK FCC CONSENT TO TRANSFER CONTROL OF LICENSES

Wayne M. Perry, Don A. Adams, and Darla Pomeroy have filed applications pursuant to Section 310(d) of the Communications Act of 1934, as amended,¹ seeking Commission consent to transfer control of broadband Personal Communications Services ("PCS") licenses currently controlled by Mr. Perry. This transfer of control would take place as the result of Mr. Perry transferring his interests in Lewis and Clark Communications, LLC ("Lewis and Clark") and Cascade Wireless, LLC ("Cascade"), along with its wholly-owned subsidiaries, to Mr. Adams and Ms. Pomeroy.² Mr. Adams and Ms. Pomeroy will collectively acquire, and share equally, a 50.1 percent economic and voting interest in Lewis and Clark,³ and a 100 percent voting interest in Cascade and its subsidiaries.⁴

GENERAL INFORMATION

The applications referenced herein have been found, upon initial review, to be acceptable for filing. The Commission reserves the right to return any application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules or policies.

Final action on these applications will not be taken earlier than 31 days following the date of this Public Notice.⁶ Interested parties may file comments or petitions to deny no later than **September 30, 2002**. Oppositions to the comments or petitions to deny may be filed no later than **October 10, 2002**. Replies to the oppositions may be filed no later than **October 18, 2002**. All filings concerning matters referenced in this Public Notice should refer to **DA 02-2133** and **WT Docket No. 02-270**, as well as the specific file numbers of the individual applications or other matters to which the filings pertain.

All documents filed in this proceeding should indicate in the caption that this matter is before the Wireless Telecommunications Bureau, Commercial Wireless Division, Policy and Rules Branch.

Under the Commission's current procedures for the submission of filings and other documents,⁷ submission in this matter may be filed electronically (*i.e.*, by the Commission's Electronic Comment Filing System (ECFS)) or by hand delivery to the Commission's Massachusetts Avenue location.

- **If filed by ECFS,**⁸ comments shall be sent as an electronic file via the Internet to
