Dear Mr. Ball:

The applicants file this Supplement to provide further updated information concerning the status of license applications or authorization requests associated with the proposed transaction.<sup>1</sup> Exhibit 1 provides a modified listing of the licenses that are the subject of the pending above-captioned assignment application.

Reference to four earth stations, E000296, E010104, E980200 and E990320, and one experimental facility, WB2XDE, have been added to the attached exhibit. As explained by the parties in their original assignment application, applications to assign these five licenses from COMSAT Corp. to Intelsat LLC were filed on April 20, 2001 and also remain pending. 
