MEMORANDUM OPINION AND ORDER

Adopted: January 30, 2002 Released: February 1, 2002

By the Chief, Enforcement Bureau:

- 1. By this *Memorandum Opinion and Order* we adopt the attached Consent Decree entered into between the Enforcement Bureau, and North County Communications Corp ("NCC"). We find that the Consent Decree provides for an appropriate resolution of the Bureau's investigation into NCC's compliance with section 52.15(f) of the Commission's rules, which requires semi-annual reporting of number utilization and forecast data.¹
- 2. Among other things, the Consent Decree provides that NCC will implement a program to ensure its future compliance with the Act and the Commission's rules and policies. In addition, the Consent Decree provides that NCC will make a voluntary contribution to the United States Treasury in the amount of \$4,800.²
- 3. We have reviewed the Consent Decree and evaluated the circumstances underlying the investigation. We believe that the public interest would be served by adopting the Consent Decree and terminating the investigatory proceeding.
- 4. ACCORDINGLY, IT IS ORDERED that, pursuant to Sections 4(i), 4(j), and 503(b) of the Communications Act of 1934, as amended,³ and Sections 0.111 and 0.311 of the Commission's rules,⁴ the Consent Decree attached hereto IS ADOPTED.
