## COMMENT SOUGHT ON CENTURYTEL WIRELESS INC. AND CENTURYTEL INC. PETITION FOR WAIVER OF CELLULAR CROSS-INTEREST RULE

WT Docket No. 02-325

## PLEADING CYCLE ESTABLISHED

On October 4, 2002, CenturyTel Wireless Inc. ("CenturyTel Wireless"), a wholly-owned subsidiary of ALLTEL Communications, Inc. ("ALLTEL"), and CenturyTel Inc. ("CenturyTel") (collectively, "the Parties") filed a petition<sup>1</sup> seeking a partial waiver of section 22.942 of the Commission's Rules ("Cellular Cross-Interest Rule").<sup>2</sup> The Parties request the partial waiver to allow CenturyTel to transfer to CenturyTel Wireless a limited partnership interest ("Interest") in Lafayette MSA LP ("Lafayette"), which holds the B-side cellular license for portions of the Louisiana-6 Rural Service Area ("RSA").<sup>3</sup> The Parties state that CenturyTel Wireless is precluded from acquiring the Interest in Lafayette without a waiver of the Cellular Cross-Interest Rule, because ALLTEL, through its subsidiary Radiofone, Inc., holds the A-side cellular license for an overlapping portion of the same RSA.<sup>4</sup> The Parties allege, *inter alia*, that waiver of the Cellular Cross-Interest Rule is appropriate because the acquisition by CenturyTel Wireless of the Interest would not lead to any anticompetitive harm.<sup>5</sup>

Pursuant to section 1.925(c)(i) of the Commission's rules,<sup>6</sup> we seek comments on the Parties' Petition. Interested parties may file comments no later than **November 18, 2002**. Oppositions may be filed no later than **December 2, 2002**. Replies may be filed no later than **December 9, 2002**. All comments filed in this proceeding should reference **DA 02-2723** and **WT Docket No. 02-325** and should indicate in the caption that this matter is before the Wireless Telecommunications Bureau, Commercial

Wireless Division. The Petition and other pleadings will be available in WT Docket No. 02-325 on the Commission's Electronic Comment Filing System ("ECFS").

Under the Commission's current procedures for the submission of filings and other documents,<sup>7</sup> submissions in this matter may be filed electronically or by hand delivery to the Commission's Massachusetts Avenue location.

- If filed by ECFS,<sup>8</sup> comments shall be sent as an electronic file via the Internet to http://www.fcc.gov/e-file/ecfs.html. Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of this proceeding, however, commenters must transmit one electronic copy of the comments to each docket or rulemaking number referenced in the caption. In completing the transmittal screen, commenters should include their full name, Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send an e-mail to ecfs@fcc.gov, and should include the following words in the body of the message, "get form <your e-mail address>." A sample form and directions will be sent in reply.
- If filed by paper, the original and four copies of each filing must be filed by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail). The Commission's contractor, Vistronix, Inc., will receive hand-delivered or messenger-delivered paper filings for the Commission's Secretary at 236 Massachusetts Avenue, N.E., Suite 110, Washington, D.C. 20002. The filing hours at this location are 8:00 a.m. to 7:00 p.m. All hand deliveries must be held together with rubber bands or fasteners. Any envelopes must be disposed of before entering the building. All filings must be addressed to the Commission's Secretary, Federal Communications Commission.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>9</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More that a one-sentence or two-sentence description of the
