By the Assistant Chief, Audio Division:

1. The Audio Division considers herein a multiple docket *Notice of Proposed Rule Makings* setting forth three separate proposals to amend the FM Table of Allotments, Section 73.202(b) of the Rules. Each proposal involves adding a community to the FM Table of Allotments. An expression of interest has been filed for each of the proposed channels. No counterproposals or additional comments have been received in response to the above-listed dockets.

A. MB Docket No. 02-226, RM-10459

Determination: Allot Channel 223A at Groom, Texas, as the community's first local aural transmission service.

Accordingly, pursuant to the authority contained in Sections 4(i), 5(c)(1), 303(g), and (r) and 307(b) of the Communications Act of 1934, as amended, and 0.61, 0.204(b) and 0.283 of the Commission's Rules, IT IS ORDERED, That effective **December 30, 2002**, the FM Table of Allotments, Section 73.202(b) of the Commission's Rules, IS AMENDED, with respect to the community listed below, as follows:

Community	Channel
Groom, Texas	223A

Additional Information: Channel 223A can be allotted to Groom with a site restriction 7.5 kilometers (4.6 miles) east of the community at coordinates **35-10-49 and 101-01-46**. Groom is an incorporated community with a population of 641 people according to the Texas State Data Center. Groom has its own local government, post office, fire department, school system, and a number of local churches.

Determination: Allot Channel 272A at Sonora, Texas, providing additional local service to the community.

Accordingly, pursuant to the authority contained in Sections 4(i), 5(c)(1), 303(g), and (r), and 307(b) of the Communications Act of 1934, as amended, and 0.61, 0.204(b) and 0.283 of the Commission's rules, IT IS ORDERED, That effective **December 30, 2002**, the FM Table of Allotments, Section 73.202(b) of the Commission's Rules, IS AMENDED, with respect to the community listed below, as follows:

Sonora, Texas	221A, 272A

Additional Information: Channel 272A can be allotted to Sonora with a site restriction 11.2 kilometers (7 miles) south of the community at coordinates **30-28-07 and 100-36-54**. Mexican concurrence has been received for the allotment of Channel 272A at Sonora. Sonora is an incorporated community with a population of 2,983 people. Sonora has its own local government, post office, fire department, school district, and its own Chamber of Commerce.

Determination: Allot Channel 254A at Spur, Texas, as the community's first local commercial FM Transmission service.

Accordingly, pursuant to the authority contained in Sections 4(i), 5(c)(1), 303(g) and (r), and 307(b) of the Communications Act of 1934, as amended, and 0.61, 0.204(b) and 0.283 of the Commission's Rules, IT IS ORDERED, That effective **December 30, 2002**, the FM Table of Allotments, Section 73.202(b) of the Commission's Rules, IS AMENDED, with respect to the community listed below, as follows:

Spur, Texas	254A

Additional Information: Channel 254A can be allotted to Spur, Texas, in compliance with the Commission's spacing requirements without a site restriction at coordinates **33-28-35 and 100-51-19**. Spur is an incorporated community with a population of 1,119 people, has its own local government, post office, fire department, school system and a number of local churches.

2. Filing windows for Channel 223A at Groom, Texas, Channel 272A at Sonora, Texas and Channel 254A at Spur, Texas, will not be opened at this time. Instead the issue of opening these allotments for auction will be addressed by the Commission in a subsequent order.
