**COMMENTS INVITED ON ACC TELECOMMUNICATIONS, LLC. AND ACC
TELECOMMUNICATIONS OF VIRGINIA, LLC (OHIO) APPLICATION TO
DISCONTINUE DOMESTIC TELECOMMUNICATIONS SERVICES**

**Applicant: ACC Telecommunications, LLC And ACC Telecommunications of
Virginia, LLC (Ohio)**

On November 12, 2002, ACC Telecommunications, LLC and ACC Telecommunications of Virginia, LLC (Ohio) (Applicants) located at **One North Main Street, Coudersport, PA 16915**, filed a joint application with the Federal Communications Commission (FCC or Commission), requesting authority under section 214(a) of the Communications Act of 1934, as amended,¹ and section 63.71 of the Commission's rules² to discontinue its domestic telecommunications services.

The application indicates that the applicants seek authority to discontinue providing facilities-based and resold interexchange service, local exchange service, and resold private line service in the Akron, Cleveland and Youngstown, Ohio metropolitan areas. The applicants have provided notice of their planned discontinuance to all affected customers by letters sent via first-class mail on November 6, 2002. The application states the applicants plan to commence discontinuance of its services 31 days after the release of this Public Notice.

In accordance with section 63.71(c), the application will be deemed to be automatically granted on the thirty-first (31st) day after the release date of this notice, unless the Commission

has notified Applicant that the grant will not be automatically effective.³ The Commission will normally authorize proposed discontinuances of service unless it is shown that customers or other end-users would be unable to receive service or a reasonable substitute from another carrier, or that the public convenience and necessity would be otherwise adversely affected.

This proceeding is considered a “permit but disclose” proceeding for purposes of the Commission's *ex parte* rules.⁴ Pursuant to sections 1.415 and 1.419 of the Commission's rules, interested parties may file comments on or before **December 9, 2002**.⁵ Such comments should refer to **Comp. Pol. File No. 622**. Comments should include specific information about the impact of this proposed discontinuance on the commenter, including any inability to acquire reasonable substitute service. The original and four (4) copies of the comments should be sent to the Office of the Secretary, Federal Communications Commission, 445 12th Street, SW, Room TW-A325, Washington, DC 20554. Two (2) copies of the comments should also be sent to the Competition Policy Division, Wireline Competition Bureau, Federal Communications Commission, 445 12th Street, SW, Room 6-A207, Washington, DC 20554, Attention: Carmell Weathers. In addition, Comments should be served upon Applicant. Commenters are also requested to fax their comments to the FCC at (202) 418-2345, Attention: John Adams.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail). The Commission's contractor, Vistrionix, Inc., will receive hand-delivered or messenger-delivered paper filings for the Commission's Secretary at 236 Massachusetts Avenue, N.E., Suite 110, Washington, D.C. 20002. The filing hours at this location are 8:00 a.m. to 7:00 p.m. All hand deliveries must be held together with rubber bands or fasteners. Any envelopes must be disposed of before entering the building.
