RE: *SBC/Ameritech Merger Order*, CC Docket No. 98-141

Dear Mr. Cartwright:

This letter addresses SBC Telecommunications, Inc.'s (SBC) September 25, 2002 letter notifying the Commission that the California Public Utility Commission (California Commission) issued an order approving changes to the Joint Partial Settlement Agreement performance measures and requesting that the Wireline Competition Bureau (Bureau) apply these California Commission-approved changes to the Carrier-to-Carrier Performance Plan (Performance Plan) for California and Nevada.<sup>1</sup> In response to SBC's request, the Bureau allowed the California Commission-approved changes to automatically go into effect for the California Performance Plan. Pursuant to the *SBC/Ameritech Merger Order*, the Chief of the Bureau has the authority to determine at the next semi-annual review whether and when SBC will make these changes in Nevada.<sup>2</sup> SBC's request to apply the California Commission-approved changes to the Nevada Performance Plan at the same time as the California changes, beginning with September 1, 2002 activity, is hereby granted.<sup>3</sup>

SBC also seeks Bureau approval to clarify two typographical errors in the business rules. Specifically, SBC requests permission to clarify the geographic reporting area for Measurements 5c (Percentage Trouble in 10 days for Non-Special Services UNE orders and 30 Days for Special Services UNE Orders) and 8 (Average Completed Interval – (DSL)). Pursuant to the *SBC/Ameritech Merger Order*, SBC's request regarding the clarification of the typographical errors is also granted.<sup>4</sup>

If SBC disagrees with any of this letter's guidance, it may file an application for review with the Commission pursuant to section 1.115 of the Commission's rules.<sup>5</sup>
