## COMMISSION SEEKS COMMENT ON AT&T REQUEST TO CONTRIBUTE TO UNIVERSAL SERVICE BASED ON PROJECTED REVENUES

## PLEADING CYCLE ESTABLISHED

On December 13, 2002, AT&T filed a request with the Commission to contribute to universal service based on its projected revenues on a going-forward basis.<sup>1</sup> Pursuant to section 54.711(c) of the Commission's rules, universal service contributions are based on a contributors' historical gross-billed end-user interstate and international telecommunications revenues, which are reported on a quarterly basis on the FCC Form 499-Q.<sup>2</sup> The FCC Form 499-Q instructs contributors to report their revenues from the prior calendar quarter.<sup>3</sup> These revenue data then serve as the basis for contributions assessed in the next calendar quarter.<sup>4</sup> AT&T asks the Commission to permit it to contribute based on its projected revenues for the current quarter, subject to true up with actual revenues, instead of contributing to universal service based on historical revenues from two quarters prior.<sup>5</sup> AT&T contends that grant of its request is warranted because the interval between reporting and assessment of contributions under the

current rules, combined with AT&T's declining interstate and international revenues, force it to recover its universal service contributions from a smaller customer base than the one on which it was assessed.<sup>6</sup> We seek comment on AT&T's request.

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments 21 days or fewer from publication in the Federal Register, and reply comments 31 days or fewer from publication in the Federal Register. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. See Electronic Filing of Documents in Rulemaking Proceedings, 63 Fed. Reg. 24,121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/e-file/ecfs.html>. Generally, only one copy of an electronic submission must be filed.
