## **ORDER**

Adopted: February 27, 2002 Released: March 1, 2002

By the Chief, Consumer Information Network Division, Consumer Information Bureau:

- 1. In this Order, we consider the complaint filed by Complainant<sup>1</sup> alleging that AT&T Corporation (AT&T) changed Complainant's telecommunications services provider without obtaining authorization and verification from Complainant in violation of the Commission's rules.<sup>2</sup> We conclude that AT&T's actions did result in an unauthorized change in Complainant's telecommunications service provider and we grant Complainant's complaint.
- 2. In December 1998, the Commission released the *Section 258 Order* in which it adopted rules to implement Section 258 of the Communications Act of 1934 (Act), as amended by the Telecommunications Act of 1996 (1996 Act).<sup>3</sup> Section 258 prohibits the practice of

"slamming," the submission or execution of an unauthorized change in a subscriber's selection of a provider of telephone exchange service or telephone toll service. In the *Section 258 Order*, the Commission adopted aggressive new rules designed to take the profit out of slamming, broadened the scope of the slamming rules to encompass all carriers, and modified its existing requirements for the authorization and verification of preferred carrier changes. The rules require, among other things, that a carrier receive individual subscriber consent before a carrier change may occur. Pursuant to Section 258, carriers are absolutely barred from changing a customer's preferred local or long distance carrier without first complying with one of the Commission's verification procedures. Specifically, a carrier must: (1) obtain the subscriber's written or electronically signed authorization in a format that meets the requirements of Section 64.1130 authorization; (2) obtain confirmation from the subscriber via a toll-free number provided exclusively for the purpose of confirming orders electronically; or (3) utilize an independent third party to verify the subscriber's order.

- 3. The Commission also has adopted liability rules. These rules require the carrier to absolve the subscriber where the subscriber has not paid his or her bill. In that context, if the subscriber has not already paid charges to the unauthorized carrier, the subscriber is absolved of liability for charges imposed by the unauthorized carrier for service provided during the first 30 days after the unauthorized change. Where the subscriber has paid charges to the unauthorized carrier, the Commission's rules require that the unauthorized carrier pay 150% of those charges to the authorized carrier, and the authorized carrier shall refund or credit to the subscriber 50% of all charges paid by the subscriber to the unauthorized carrier.
- 4. We received Complainant's complaint on September 17, 2001, alleging that Complainant's intraLATA toll and long distance services had been changed from Qwest. Communications to AT&T without Complainant's authorization. Pursuant to Sections 1.719 and 64.1150 of our rules, <sup>10</sup> we notified AT&T of the complaint and AT&T responded on November 19, 2001. AT&T states that the Complainant's intraLATA toll and long distance services were

switched by someone cashing a promotional check. It also states that the name and address on the check differ from the Complainant's and that the check was signed by the previous customer. We find that AT&T has failed to produce clear and convincing evidence that the Complainant authorized a carrier change.<sup>12</sup> Therefore, we find that AT&T's actions resulted in an unauthorized change in Complainant's intraLATA toll and long distance providers and we discuss AT&T's liability below.<sup>13</sup>

- 5. AT&T has removed all charges incurred for service provided to Complainant for the first thirty days after the alleged unauthorized change in accordance with the Commission's liability rules. We have determined that Complainant is entitled to absolution for the charges incurred during the first thirty days after the unauthorized change occurred and that neither Qwest Communications nor AT&T may pursue any collection against Complainant for those charges. Any charges imposed by AT&T on the subscriber for service provided after this 30-day period shall be paid by the subscriber to Qwest Communications at the rates the subscriber was paying to the authorized carrier at the time of the unauthorized change of intraLATA toll and long distance services. - 6. Accordingly, IT IS ORDERED that, pursuant to Section 258 of the Communications Act of 1934, as amended, 47 U.S.C. § 258, and Sections 0.141, 0.361 and 1.719 of the Commission's rules, 47 C.F.R. §§ 0.141, 0.361, 1.719, the complaint filed against AT&T Corporation IS GRANTED.
- 7. IT IS FURTHER ORDERED that, pursuant to Section 64.1170(d) of the Commission's rules, 47 C.F.R. § 64.1170(d), Complainant is entitled to absolution for the charges incurred during the first thirty days after the unauthorized change occurred neither Qwest Communications nor AT&T Corporation may pursue any collection against Complainant for those charges.

Such filing will be deemed to relate back to the filing date of Complainant's informal complaint so long as the formal complaint is filed within 45 days from the date this order is mailed or delivered electronically to Complainant. *See* 47 C.F.R. § 1.719.
