## I. PETITION FOR WAIVER

1. In this public notice, we seek comment on a petition filed by ALLTEL Corporation (ALLTEL) on February 22, 2002. Specifically, ALLTEL requests that the Commission extend the interim waiver of the "all-or-nothing" rule, initially granted in 2000, to allow ALLTEL, a rate-of-return carrier, to continue to file price-cap tariffs for certain exchanges acquired in a merger with Aliant Communications (Aliant). ALLTEL requests an extension of the waiver from July 1, 2002 until July 1,

The "all-or-nothing" rule mandates that, if a carrier files a price-cap tariff for one study area, the carrier and its affiliates, except its average schedule affiliates, must file price-cap tariffs for all of their study areas. The rule also requires that, when a price-cap carrier acquires, is acquired by, merges with, or otherwise becomes affiliated with a non-price cap carrier, the non-price cap carrier shall become subject to price-cap regulation.

## II. PROCEDURAL MATTTERS

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>5</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and arguments presented is generally required.<sup>6</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>7</sup>
- 3. Interested parties may file comments no later than March 25, 2002. Reply comments may be filed no later than April 1, 2002. When filing comments, please reference the internal file number: CCB/CPD 99-01.
- 4. An original and four copies of all pleadings shall be filed with the Secretary of the Commission.
