**ORDER**

By the Telecommunications Access Policy Division, Wireline Competition Bureau:

1. Before the Accounting Policy Division is a Request for Review filed by Nathaniel Hawthorne on behalf of Putnam County School District, Winfield, West Virginia (Putnam), seeking review of a decision issued by the Schools and Libraries Division (SLD) of the Universal Service Administrative Company (Administrator).<sup>1</sup> Putnam seeks review of SLD's denial of Putnam's request for discounted services in Funding Year 4.<sup>2</sup> SLD denied Putnam's request because it stated that Putnam did not postmark its FCC Form 471, Block 6 certifications, and/or Item 21 attachments by the deadline for the Funding Year 4 filing window.<sup>3</sup> However, since the Request for Review was filed, SLD has granted the relief that Putnam is seeking.<sup>4</sup> Putnam's Request for Review is therefore dismissed as moot.
