ORDER

By the Telecommunications Access Policy Division, Wireline Competition Bureau:

1. Before the Telecommunications Access Policy Division is a Request for Review filed by Webermeier Memorial Library (Webermeier), Milford, Nebraska, seeking review of a decision issued by the Schools and Libraries Division (SLD) of the Universal Service Administrative Company (Administrator).¹ Webermeier seeks review of SLD's denial of Webermeier's request to have discounted services for Funding Year 4.² SLD denied Webermeier's request because its FCC Form 471 application, Block 6 Certifications, and/or Item 21 attachments were postmarked after the 2001-2002 filing window closed on January 18, 2001.³ However, since the Request for Review was filed, SLD has granted the relief that Webermeier is seeking.⁴ Webermeier's Request for Review is therefore dismissed as moot.
