**ORDER**

**Adopted: April 24, 2003**

**Released: April 29, 2003**

By the Acting Deputy Chief, Policy Division, Consumer & Governmental Affairs Bureau:

1. In this Order, we consider the complaint filed by Complainant<sup>1</sup> alleging that Cox Rhode Island Telcom, LLC (Cox) changed Complainant's telecommunications service provider without obtaining authorization and verification from Complainant in violation of the Commission's rules.<sup>2</sup> We conclude that Cox's actions did result in an unauthorized change in Complainant's telecommunications service provider and we grant Complainant's complaint.

2. In December 1998, the Commission released the *Section 258 Order* in which it adopted rules to implement Section 258 of the Communications Act of 1934 (Act), as amended by the Telecommunications Act of 1996 (1996 Act).<sup>3</sup> Section 258 prohibits the practice of "slamming," the submission or execution of an unauthorized change in a subscriber's selection

of a provider of telephone exchange service or telephone toll service.<sup>4</sup> In the *Section 258 Order*, the Commission adopted aggressive new rules designed to take the profit out of slamming, broadened the scope of the slamming rules to encompass all carriers, and modified its existing requirements for the authorization and verification of preferred carrier changes. The rules require, among other things, that a carrier receive individual subscriber consent before a carrier change may occur.<sup>5</sup> Pursuant to Section 258, carriers are absolutely barred from changing a customer's preferred local or long distance carrier without first complying with one of the Commission's verification procedures.<sup>6</sup> Specifically, a carrier must: (1) obtain the subscriber's written or electronically signed authorization in a format that meets the requirements of Section 64.1130 authorization; (2) obtain confirmation from the subscriber via a toll-free number provided exclusively for the purpose of confirming orders electronically; or (3) utilize an independent third party to verify the subscriber's order.<sup>7</sup>

3. The Commission also has adopted liability rules. These rules require the carrier to absolve the subscriber where the subscriber has not paid his or her bill. In that context, if the subscriber has not already paid charges to the unauthorized carrier, the subscriber is absolved of liability for charges imposed by the unauthorized carrier for service provided during the first 30 days after the unauthorized change.<sup>8</sup> Where the subscriber has paid charges to the unauthorized carrier, the Commission's rules require that the unauthorized carrier pay 150% of those charges to the authorized carrier, and the authorized carrier shall refund or credit to the subscriber 50% of all charges paid by the subscriber to the unauthorized carrier.<sup>9</sup> Carriers should note that our actions in this order do not preclude the Commission from taking additional action, if warranted, pursuant to Section 503 of the Act.<sup>10</sup>

4. We received Complainant's complaint on January 22, 2003, alleging that Complainant's telecommunications service provider had been changed from their authorized carrier to Cox without Complainant's authorization. Pursuant to Sections 1.719 and 64.1150 of our rules,<sup>11</sup> we notified Cox of the complaint and Cox responded on March 19, 2003.<sup>12</sup> Cox

states that authorization was received and confirmed through third party verification. However, Complainant did not give authorization to have their interLATA service switched. Cox states that Complainant's interLATA service was switched due to a manual error. We find that Cox has failed to produce clear and convincing evidence that Complainant authorized a carrier change.<sup>13</sup> Therefore, we find that Cox's actions resulted in an unauthorized change in Complainant's telecommunications service provider and we discuss Cox's liability below.<sup>14</sup>

5. Pursuant to Section 64.1170(b) our rules, Cox must forward to WorldCom, Inc. (WorldCom) Complainant's authorized carrier an amount equal to 150% of all charges paid by the subscriber to Cox.<sup>15</sup> Therefore, Cox must forward to WorldCom 150% of the amount, along with copies of any telephone bills issued from the company to the Complainant.<sup>16</sup> Within ten days of receipt of this amount, WorldCom shall provide a refund or credit to Complainant in the amount of 50% of all charges paid by Complainant to Cox. Complainant has the option of asking WorldCom to re-rate Cox's charges based on WorldCom's rates and, on behalf of Complainant, seek from Cox, any re-rated amount exceeding 50% of all charges paid by Complainant to Cox. WorldCom must also send a notice to the Commission, referencing this Order, stating that it has given a refund or credit to Complainant.<sup>17</sup> If WorldCom has not received the reimbursement required from Cox within 45 days of the release of this Order, WorldCom must notify the Commission and Complainant accordingly. WorldCom also must notify the Complainant of his or her right to pursue a claim against Cox for a refund of all charges paid to Cox.<sup>18</sup>

6. Accordingly, IT IS ORDERED that, pursuant to Section 258 of the Communications Act of 1934, as amended, 47 U.S.C. § 258, and Sections 0.141, 0.361 and 1.719 of the Commission's rules, 47 C.F.R. §§ 0.141, 0.361, 1.719, the complaint filed by Complainant against Cox IS GRANTED.

7. IT IS FURTHER ORDERED that, pursuant to Section 64.1170(b) of the Commission's rules, 47 C.F.R. § 64.1170(b), that Cox must forward to WorldCom an amount equal to 150% of all charges paid by the subscriber along with copies of any telephone bills issued from the company to the Complainant within ten (10) days of the release of this order.
