**ORDER**

**Adopted: April 24, 2003**

By the Acting Deputy Chief, Policy Division, Consumer & Governmental Affairs Bureau:

1. In this Order, we consider the complaint filed by Complainant<sup>1</sup> alleging that OneLink Communications, Inc. (OneLink) changed Complainant's telecommunications service provider without obtaining authorization and verification from Complainant in violation of the Commission's rules.<sup>2</sup> We conclude that OneLink's actions did result in an unauthorized change in Complainant's telecommunications service provider and we grant Complainant's complaint.

2. In December 1998, the Commission released the *Section 258 Order* in which it adopted rules to implement Section 258 of the Communications Act of 1934 (Act), as amended by the Telecommunications Act of 1996 (1996 Act).<sup>3</sup> Section 258 prohibits the practice of "slamming," the submission or execution of an unauthorized change in a subscriber's selection

of a provider of telephone exchange service or telephone toll service.<sup>4</sup> In the *Section 258 Order*, the Commission adopted aggressive new rules designed to take the profit out of slamming, broadened the scope of the slamming rules to encompass all carriers, and modified its existing requirements for the authorization and verification of preferred carrier changes. The rules require, among other things, that a carrier receive individual subscriber consent before a carrier change may occur.<sup>5</sup> Pursuant to Section 258, carriers are absolutely barred from changing a customer's preferred local or long distance carrier without first complying with one of the Commission's verification procedures.<sup>6</sup> Specifically, a carrier must: (1) obtain the subscriber's written or electronically signed authorization in a format that meets the requirements of Section 64.1130 authorization; (2) obtain confirmation from the subscriber via a toll-free number provided exclusively for the purpose of confirming orders electronically; or (3) utilize an independent third party to verify the subscriber's order.<sup>7</sup>

3. The Commission also has adopted liability rules. These rules require the carrier to absolve the subscriber where the subscriber has not paid his or her bill. In that context, if the subscriber has not already paid charges to the unauthorized carrier, the subscriber is absolved of liability for charges imposed by the unauthorized carrier for service provided during the first 30 days after the unauthorized change.<sup>8</sup> Where the subscriber has paid charges to the unauthorized carrier, the Commission's rules require that the unauthorized carrier pay 150% of those charges to the authorized carrier, and the authorized carrier shall refund or credit to the subscriber 50% of all charges paid by the subscriber to the unauthorized carrier.<sup>9</sup> Carriers should note that our actions in this order do not preclude the Commission from taking additional action, if warranted, pursuant to Section 503 of the Act.<sup>10</sup>

4. We received Complainant's complaint on October 3, 2002, alleging that Complainant's telecommunications service provider had been changed from their authorized carrier to OneLink without Complainant's authorization. Pursuant to Sections 1.719 and 64.1150 of our rules,<sup>11</sup> we notified OneLink of the complaint and OneLink responded on

December 19, 2002.<sup>12</sup> OneLink states that authorization was received and confirmed through third party verification. OneLink's verifier, however, did not obtain separate authorizations for each service sold as required by our rules.<sup>13</sup> We find that OneLink has failed to produce clear and convincing evidence that Complainant authorized a carrier change.<sup>14</sup> Therefore, we find that OneLink's actions resulted in an unauthorized change in Complainant's telecommunications service provider and we discuss OneLink's liability below.<sup>15</sup>

5. Pursuant to Section 64.1170(b) our rules, OneLink must forward to Sprint Communications Company (Sprint) an amount equal to 150% of all charges paid by the subscriber to OneLink.<sup>16</sup> Therefore, OneLink must forward to Sprint 150% of the amount, along with copies of any telephone bills issued from the company to the Complainant.<sup>17</sup> Within ten days of receipt of this amount, Sprint shall provide a refund or credit to Complainant in the amount of 50% of all charges paid by Complainant to OneLink. Complainant has the option of asking Sprint to re-rate OneLink's charges based on Sprint's rates and, on behalf of Complainant, seek from OneLink, any re-rated amount exceeding 50% of all charges paid by Complainant to OneLink. Sprint must also send a notice to the Commission, referencing this Order, stating that it has given a refund or credit to Complainant.<sup>18</sup> If Sprint has not received the reimbursement required from OneLink within 45 days of the release of this Order, Sprint must notify the Commission and Complainant accordingly. Sprint also must notify the Complainant of his or her right to pursue a claim against OneLink for a refund of all charges paid to OneLink.<sup>19</sup>

6. OneLink has removed all charges incurred for service provided to Complainant for the first thirty days after the alleged unauthorized change in accordance with the Commission's liability rules.<sup>20</sup> We have determined that Complainant is entitled to absolution for the charges incurred during the first thirty days after the unauthorized change occurred and

that neither Sprint nor OneLink may pursue any collection against Complainant for those charges.<sup>21</sup> Any charges imposed by OneLink on the subscriber for service provided after this 30-day period shall be paid by the subscriber to Sprint at the rates the subscriber was paying to the authorized carrier at the time of the unauthorized change.<sup>22</sup>

7. Accordingly, IT IS ORDERED that, pursuant to Section 258 of the Communications Act of 1934, as amended, 47 U.S.C. § 258, and Sections 0.141, 0.361 and 1.719 of the Commission's rules, 47 C.F.R. §§ 0.141, 0.361, 1.719, the complaint filed by Complainant against OneLink IS GRANTED.

8. IT IS FURTHER ORDERED that, pursuant to Section 64.1170(b) of the Commission's rules, 47 C.F.R. § 64.1170(b), that OneLink must forward to Sprint an amount equal to 150% of all charges paid by the subscriber along with copies of any telephone bills issued from the company to the Complainant within ten (10) days of the release of this order.

9. IT IS FURTHER ORDERED that this Order is effective upon release.
