**NORTH AMERICAN NUMBERING PLAN BILLING AND COLLECTION, INC.
(NBANC) SUBMITS THE CONTRIBUTION FACTOR AND FUND SIZE ESTIMATE
FOR NORTH AMERICAN NUMBERING PLAN ADMINISTRATION FOR JULY 2003
THROUGH JUNE 2004**

On May 6, 2003, pursuant to 47 C.F.R. § 52.16(a), the North American Numbering Plan Billing and Collection, Inc. (NBANC) submitted the contribution factor and fund size estimate for funding North American Numbering Plan Administration for the period July 2003 through June 2004.¹ The NBANC Board of Directors, by resolution at its April 25, 2003 meeting, authorized the contribution factor filed therein.

The NBANC Board of Directors recommends a contribution factor of 0.000036 for the upcoming fund year. The contribution factor for the current fund year is 0.000043. NBANC recommends a fund size of \$12.1 million for the period July 2003 through June 2004. It seeks to collect \$8.25 million from domestic telecommunications service providers, \$179,888 from international participants, and to apply \$3.67 million from the previous fund year's balance to satisfy the proposed fund size.

Pursuant to Sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on or before **May 30, 2003**, and reply comments on or before **June 6, 2003**. Comments may be filed using the Commission's Electronic Filing System (ECFS) or by filing paper copies. See Electronic Filing of Documents in Rulemaking Proceedings, 63 Fed. Reg 24121 (1998). All comments must reference **CC Docket 92-237**. If filing paper copies, send an original and four copies to the Commission Secretary, Marlene H. Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/e-file/ecfs.html>. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic copy by Internet e-mail. To get filing instructions for e-mail comments, commenters should send an e-mail to ecfs@fcc.gov, and should include the following words in the body of the message, "get form <your e-mail address>." Parties who choose to file by paper must file an original and four copies of each filing. Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail). The Commission's contractor, Vistrionix, Inc., will receive hand-delivered or messenger-delivered paper filings for the Commission's Secretary at 236 Massachusetts Avenue, N.E., Suite 110, Washington, D.C. 20002. The filing hours at this location are 8:00 a.m. to 7:00 p.m. All hand deliveries must be held together with rubber bands or fasteners. Any envelopes must be disposed of before entering the building. Commercial overnight mail (other than U.S. Postal Service Express Mail and Priority Mail) must be sent to 9300 East Hampton Drive, Capitol Heights, MD 20743. U.S. Postal Service first-class mail, Express Mail, and Priority Mail should be addressed to 445 12th Street, SW, Washington, D.C. 20554. All filings must be addressed to the Commission's Secretary, Federal Communications Commission.

Commission's rules applicable to non-restricted proceedings. 47 C.F.R. § 1.1206.

Parties making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must contain a summary of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented is generally required. *See* 47 C.F.R. § 1.1206(b)(2). Other rules pertaining to oral and written presentations are set forth in Section 1.1206(b) as well.
