## SBC COMMUNICATIONS INC. FILES COST ALLOCATION MANUAL REVISION

#### I. COST ALLOCATION MANUAL REVISION

1. In this public notice, we seek comment on the Cost Allocation Manual (CAM) revision filed by SBC Communications Inc. on July 31, 2003, on behalf of Ameritech, Nevada Bell, Pacific Bell and Southwestern Bell Telephone companies. Specifically, SBC Communications Inc. has filed changes to the nonregulated activities, transactions with affiliates, and cost apportionment sections of the CAM.

#### II. PROCEDURAL MATTERS

2. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>1</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and arguments presented is generally required.<sup>2</sup> Other rules

pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>3</sup>

3. Interested parties may file comments no later than September 15, 2003. Reply comments may be filed no later than September 30, 2003.
