**WIRELINE COMPETITION BUREAU SEEKS COMMENT ON
PETITION OF GRANDE COMMUNICATIONS INC. FOR WAIVER OF SECTIONS
54.307(C) AND 54.314(D) OF THE COMMISSION'S RULES**

On June 30, 2003, Grande Communications, Inc. (Grande), a competitive eligible communications carrier, filed a petition with the Commission seeking waiver of the December 30, 2002 deadline set forth in section 54.307(c)(4) of the Commission's rules for filing line-count data with the Universal Service Administrative Company (USAC).¹ In addition, Grande requests a waiver of the January 1, 2003 deadline set forth in section 54.314(d)(2) of the Commission's rules for the Public Utilities Commission of Texas (Texas PUC) to file an annual certification with the USAC and the Commission stating that all universal service high-cost support received by Grande will be used "only for the provision, maintenance, and upgrading of facilities and services for which support is intended."² Grande's waiver request relates to its receipt of high-cost support for service provided in the state of Texas. Grande contends that granting its request for waiver of sections 54.307 and 54.314 is appropriate in light of the delay associated with its ETC designation. Specifically, Grande contends that because its ETC designation occurred on May 22, 2003, it could not have met the December 30, 2002 line count filing deadline or the Texas PUC could not have met the January 1, 2003 certification filing deadline, both of which

must be satisfied to receive support in second quarter 2003.³ Grande further argues that granting its waiver request will advance the public interest by promoting the availability of competitive telecommunications services in high-cost areas in Texas and adhering to the Commission's principle of competitive neutrality.⁴ Grande, therefore, requests that the Commission grant its waiver request so that it can receive high-cost support as of May 22, 2003, the date Grande received its ETC designation.

We invite comment on the Petition for Waiver. Pursuant to applicable procedures set forth in sections 1.415 and 1.419 of the Commission's rules, interested parties may file comments on or before **August 29, 2003**; and reply comments on or before **September 12, 2003**. All filings should refer to CC Docket No. 96-45. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. The Commission will also send a copy of this Public Notice to the Texas PUC by overnight express mail to ensure that the Texas PUC is notified of the notice and comment period.

Comments filed through ECFS can be sent as an electronic file via the Internet to <<http://www.fcc.gov/e-file/ecfs.html>>. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, commenters should include their full name, Postal Service mailing address, and the applicable docket number, which in this instance is CC Docket No. 96-45. Parties may also submit an electronic comment by Internet e-mail. To receive filing instructions for e-mail comments, commenters should send an e-mail to ecfs@fcc.gov, and should include the following words in the body of the message: get form <your e-mail address>. A sample form and directions will be sent in reply.

Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, commenters must submit two additional copies for each additional docket or rulemaking number. Parties who choose to file by paper are hereby notified that effective December 18, 2001, the Commission's contractor, Vistrionix, Inc., will receive hand-delivered or messenger-delivered paper filings for the Commission's Secretary at a new location in downtown Washington, DC. The address is 236 Massachusetts Avenue, NE, Suite 110, Washington, DC, 20002. The filing hours at this location will be 8:00 a.m. to 7:00 p.m. All hand deliveries must be held together with rubber bands or fasteners. Any envelopes must be disposed of before entering the building. This facility is the only location where hand-delivered or messenger-delivered paper filings for the Commission's Secretary will be accepted.
