**PLEADING CYCLE ESTABLISHED FOR COMMENTS ON BELLSOUTH'S
REQUEST FOR DECLARATORY RULING THAT STATE COMMISSIONS MAY NOT
REGULATE BROADBAND INTERNET ACCESS SERVICES BY REQUIRING BELLSOUTH TO
PROVIDE SUCH SERVICES TO CLEC VOICE CUSTOMERS**

On December 9, 2003, BellSouth Telecommunications, Inc. (BellSouth) filed a request for declaratory ruling that the state commissions may not regulate broadband Internet access services by requiring BellSouth to provide wholesale or retail broadband services to voice service customers of competitive local exchange carriers (CLECs) using unbundled network elements (UNEs). BellSouth requests that the Commission issue an expedited declaratory ruling specifying that: (1) state commission decisions requiring incumbent local exchange carriers (ILECs) to provide broadband Internet access to CLEC UNE voice service customers are contrary to the *Triennial Review Order* and thus must be preempted; (2) state commission decisions requiring the provision of broadband Internet access to CLEC UNE voice service customers impose state regulation on interstate information services in contravention of this Commission's *Computer Inquiry* decisions; and (3) state commission decisions specifying the terms and conditions under which ILECs provide federally tariffed broadband transmission either on its own or as part of a broadband information service intrude on this Commission's exclusive authority over interstate telecommunications and thus are unlawful.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. See 47 C.F.R. §§ 1.1200, 1.1206. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required. See 47 C.F.R. § 1.1206(b). Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in Section 1.1206(b) of the Commission's rules, 47 C.F.R. § 1.1206(b).

Pursuant to Section 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on the petition for forbearance or before **January 15, 2004** and reply comments of or before **January 30, 2004**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. See Electronic Filing of Documents in Rulemaking Proceedings, 63 Fed. Reg. 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/e-file/ecfs.html>. Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of this proceeding, however, commenters must transmit one electronic copy of the comments to each docket or rulemaking number referenced in the caption.
