**REPORT AND ORDER
(Proceeding Terminated)**

By the Chief, Video Division:

1. At the request of Macon Urban Ministries, Inc. d/b/a Good News Television (“Good News”), licensee of station WGNM, Macon, Georgia, the Commission has before it the Notice of Proposed Rule Making, 17 FCC Rcd 17199 (2002), proposing the substitution of DTV channel 45 for WGNM’s DTV channel 50. Good News filed comments. No other comments were received.

2. Good News filed comments stating that adoption of its channel substitution proposal will eliminate the potential for interference to four NTSC and DTV channel allotments.¹ Good News also asserts that the allotment of DTV channel 45 will remove the mutual exclusivity between its current DTV channel 50 and a pending application for DTV channel 51 at Cordele, Georgia. Furthermore, Good News claims that its operation on DTV channel 45 will enable station WGNM to increase its DTV service area to include 89,848 more people, a gain of 14.4%.

2. We believe the public interest would be served by allotting DTV channel 45 in lieu of DTV channel 50 since it will enable station WGNM to eliminate the potential for interference to a number of NTSC and DTV channel allotments. DTV channel 45 can be allotted to Macon, Georgia, as proposed, in compliance with the principle community coverage requirement of Section 73.625(a) at coordinates 32-45-51 N. and 83-33-32 W. In addition, we find that this channel is acceptable under the 2 percent criterion for *de minimis* impact that is applied in evaluating requests for modification of initial DTV allotments under Section 73.623(c)(2) for Station WGNM-DT with the following specifications:

3. Accordingly, pursuant to the authority contained in Sections 4(i), 5(c)(1), 303(g) and (r) and 307(b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204(b) and 0.283 of the Commission's Rules, IT IS ORDERED, That effective March 3, 2003, the DTV Table of Allotments, Section 73.622(b) of the Commission's Rules, IS AMENDED, with respect to the community listed below, to read as follows:

4. IT IS FURTHER ORDERED, That within 45 days of the effective date of this Order, Macon Urban Ministries, Inc. shall submit to the Commission a minor change application for a construction permit (FCC Form 301) specifying DTV Channel 45 in lieu of DTV Channel 50 for station WGNM-DT.

5. IT IS FURTHER ORDERED, That this proceeding IS TERMINATED.
