ORDER

By the Deputy Chief, Consumer Policy Division, Consumer & Governmental Affairs Bureau:

1. In this Order, we consider the complaint filed by Complainant¹ alleging that IDT Corporation (IDT) changed Complainant's telecommunications service provider without obtaining authorization and verification from Complainant in violation of the Commission's rules.² We conclude that IDT's actions did result in an unauthorized change in Complainant's telecommunications service provider and we grant Complainant's complaint.

2. In December 1998, the Commission released the *Section 258 Order* in which it adopted rules to implement Section 258 of the Communications Act of 1934 (Act), as amended by the Telecommunications Act of 1996 (1996 Act).³ Section 258 prohibits the practice of "slamming," the submission or execution of an unauthorized change in a subscriber's selection

of a provider of telephone exchange service or telephone toll service.⁴ In the *Section 258 Order*, the Commission adopted aggressive new rules designed to take the profit out of slamming, broadened the scope of the slamming rules to encompass all carriers, and modified its existing requirements for the authorization and verification of preferred carrier changes. The rules require, among other things, that a carrier receive individual subscriber consent before a carrier change may occur.⁵ Pursuant to Section 258, carriers are absolutely barred from changing a customer's preferred local or long distance carrier without first complying with one of the Commission's verification procedures.⁶ Specifically, a carrier must: (1) obtain the subscriber's written or electronically signed authorization in a format that meets the requirements of Section 64.1130 authorization; (2) obtain confirmation from the subscriber via a toll-free number provided exclusively for the purpose of confirming orders electronically; or (3) utilize an independent third party to verify the subscriber's order.⁷

3. The Commission also has adopted liability rules. These rules require the carrier to absolve the subscriber where the subscriber has not paid his or her bill. In that context, if the subscriber has not already paid charges to the unauthorized carrier, the subscriber is absolved of liability for charges imposed by the unauthorized carrier for service provided during the first 30 days after the unauthorized change.⁸ Where the subscriber has paid charges to the unauthorized carrier, the Commission's rules require that the unauthorized carrier pay 150% of those charges to the authorized carrier, and the authorized carrier shall refund or credit to the subscriber 50% of all charges paid by the subscriber to the unauthorized carrier.⁹ Carriers should note that our actions in this order do not preclude the Commission from taking additional action, if warranted, pursuant to Section 503 of the Act.¹⁰

4. We received Complainant's complaint on September 18, 2002 alleging that Complainant's telecommunications service provider had been changed from Southwestern Bell Telephone to IDT without Complainant's authorization. Pursuant to Sections 1.719 and 64.1150 of our rules,¹¹ we notified IDT of the complaint and IDT responded on November 8, 2002.¹²

IDT states that authorization was received and confirmed through a third party verification company. IDT's verifier, however, failed to confirm that the person on the call was authorized to make the carrier change as required by our rules.¹³ We find that IDT has failed to produce clear and convincing evidence that Complainant authorized a carrier change.¹⁴ Therefore, we find that IDT's actions resulted in an unauthorized change in Complainant's telecommunications service provider and we discuss IDT's liability below.¹⁵

5. IDT must remove all charges incurred for service provided to Complainant for the first thirty days after the alleged unauthorized change in accordance with the Commission's liability rules.¹⁶ We have determined that Complainant is entitled to absolution for the charges incurred during the first thirty days after the unauthorized change occurred and that neither Covista nor IDT may pursue any collection against Complainant for those charges.¹⁷ Any charges imposed by IDT on the subscriber for service provided after this 30-day period shall be paid by the subscriber to their authorized carrier at the rates the subscriber was paying to Covista at the time of the unauthorized change.¹⁸

6. Accordingly, IT IS ORDERED that, pursuant to Section 258 of the Communications Act of 1934, as amended, 47 U.S.C. § 258, and Sections 0.141, 0.361 and 1.719 of the Commission's rules, 47 C.F.R. §§ 0.141, 0.361, 1.719, the complaint filed by Complainant against IDT IS GRANTED.

7. IT IS FURTHER ORDERED that, pursuant to Section 64.1170(d) of the Commission's rules, 47 C.F.R. § 64.1170(d), Complainant is entitled to absolution for the charges incurred during the first thirty days after the unauthorized change occurred and neither Covista nor IDT may pursue any collection against Complainant for those charges.

We recognize that a carrier may have, in accordance with our rules, filed a certification with the Commission stating that the carrier's sales agent is unable (due to, for example, technical reasons) to drop off the call once the agent has established the three way connection with the third party verifier and the customer. However, even if a carrier has filed such a certification, final verification may only be validly obtained after the sales agent has finished providing information. If additional information is provided by the sales agent during a verification attempt, the third party verification must be terminated, and a new verification may commence only after the carrier's sales agent has finished providing information.
