PLEADING CYCLE ESTABLISHED FOR PETITION OF AUTOTEL FOR PREEMPTION PURSUANT TO SECTION 252(e)(5)

WC DOCKET NO. 04-311

Comments Due: August 24, 2004
Reply Comments Due: September 3, 2004

On July 30, 2004, Autotel filed a petition pursuant to section 252(e)(5) of the Communications Act, as amended (Act), and section 51.803 of the Commission's rules for preemption of the jurisdiction of the Public Utilities Commission of Nevada (Nevada Commission). Autotel requests that the Commission issue an order preempting the jurisdiction of the Nevada Commission for failing to act on a specific request for arbitration of an interconnection agreement with SBC pursuant to section 252(b)(4)(C) of the Act.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. See 47 C.F.R. §§ 1.1200, 1.1206. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required. See 47 C.F.R. § 1.1206(b). Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules. 47 C.F.R. § 1.1206(b).

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on Autotel's petition on or before **August 24, 2004**, and reply comments on or before **September 3, 2004**. All filings must be addressed to the Commission's Secretary, Marlene H. Dortch, Office of the Secretary, Federal Communications Commission, 445 12th Street, SW, Suite TW-A325, Washington, DC 20554. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. See Electronic Filing of Documents in Rulemaking Proceedings, 63 Fed. Reg. 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/e-file/ecfs.html>. Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of this proceeding, however,

commenters must transmit one electronic copy of the comments to each docket or rulemaking number referenced in the caption. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. Parties who choose to file by paper must file an original and four copies of each filing.
