By the Chief, Telecommunications Access Policy Division, Wireline Competition Bureau:

1. The Telecommunications Access Policy Division has under consideration a Request for Review filed by Mackenzie Hughes LLP on behalf of Onondaga-Cortland-Madison BOCES, Syracuse, New York (OCM BOCES). OCM BOCES seeks Billed Entity Applicant Reimbursement (BEAR) payment assistance for Funding Year 2000 of the schools and libraries universal service mechanism. Upon our review of the record, however, we find that SLD approved OCM BOCES's request for BEAR payment assistance for Funding Request Numbers 471531, 471623, 480855.
