COMMENTS SOUGHT ON VERIZON NEW JERSEY INC. REQUEST FOR LIMITED MODIFICATION OF LATA BOUNDARIES IN NEW JERSEY

By this Public Notice, we seek comment on a petition filed by Verizon New Jersey Inc. requesting modification of local access and transport area (LATA) boundaries to provide two-way service between the North Jersey and Delaware Valley LATAs to permit service through a single exchange to a new residential housing development that would otherwise be served by two exchanges in different LATAs.¹

Interested parties may file comments concerning this request on or before **February 19, 2004**, and reply comments on or before **February 26, 2004**. All filings must reference **CC Docket No. 96-159**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 Fed. Reg. 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <<http://www.fcc.gov/e-file/ecfs.html>>. Only one copy of an electronic submission must be filed. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send e-mail to ecfs@fcc.gov, and should include the following words in the subject line "get form <your e-mail address>." A sample form and directions will be sent in reply.
