**THE WIRELINE COMPETITION BUREAU SEEKS COMMENT ON
PETITION TO REDEFINE A RURAL TELEPHONE COMPANY SERVICE AREA IN THE
STATE OF WEST VIRGINIA**

The Wireline Competition Bureau seeks comment on a petition filed by the Public Service Commission of West Virginia (West Virginia Commission), pursuant to section 54.207(c) of the Commission's rules, requesting Federal Communications Commission agreement with the West Virginia Commission's decision to redefine the service area of the rural telephone company, Citizens Telecommunications Company of West Virginia d/b/a Frontier Communications of West Virginia¹

This is the Public Notice required by section 54.207(c)(2).² If the Commission initiates a proceeding to consider the Petition, it must do so within ninety (90) days from the release of this Public Notice.³ If the Commission does not act on the Petition within 90 days of the release of this Public Notice, the definition proposed by the West Virginia Commission will be deemed approved by the Commission and shall take effect in accordance with state procedures.⁴

Pursuant to Sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on or before **November 8, 2004**, and reply comments on or before

November 22, 2004. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.⁵

Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/cgb/ecfs/>. Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of this proceeding, however, commenters must transmit one electronic copy of the comments to each docket or rulemaking number referenced in the caption. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send an e-mail to ecfs@fcc.gov, and should include the following words in the body of the message, "get form." A sample form and directions will be sent in reply. Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, commenters must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail).
