**PLEADING CYCLE ESTABLISHED FOR COMMENTS
ON BELL SOUTH'S PETITION FOR REQUEST FOR LIMITED MODIFICATION OF THE LATA
BOUNDARY TO PROVIDE EXTENDED AREA SERVICE BETWEEN CERTAIN EXCHANGES
IN THE STATE OF NORTH CAROLINA**

By this Public Notice, we seek comment on a petition filed on November 4, 2004 by BellSouth Corporation (BellSouth) requesting a limited modification of the LATA boundary to provide extended area service between the Kenly exchange in the Rocky Mount LATA and the Raleigh exchange in the Raleigh LATA, and between the Princeton exchange in the Fayetteville LATA and the Raleigh exchange in the Raleigh LATA, in the State of North Carolina. All of the exchanges are in North Carolina.

This Public Notice establishes certain procedural requirements relating to consideration of BellSouth's petition. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. See 47 C.F.R. §§ 1.1200, 1.1206. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required. See 47 C.F.R. § 1.1206(b). Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in Section 1.1206(b) of the Commission's rules, 47 C.F.R. § 1.1206(b).

Pursuant to Section 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on BellSouth's petitions on or before **November 24, 2004** and reply comments on or before **December 06, 2004**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.

Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appear in the caption of this proceeding, commenters must submit two additional copies for each additional docket or rulemaking number.
