**PARTIES ARE INVITED TO COMMENT ON TRACFONE WIRELESS' PETITIONS FOR  
DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER IN  
CONNECTICUT AND MASSACHUSETTS**

Interested parties are invited to comment on two petitions filed on November 9, 2004 by TracFone Wireless, Inc. (TracFone), a provider of commercial mobile radio services (CMRS) seeking designation as an eligible telecommunications carrier (ETC) for the entire states of Connecticut and Massachusetts pursuant to section 214(e)(6) of the Communications Act of 1934, as amended.<sup>1</sup> In addition, because TracFone provides CMRS only through resale, TracFone previously filed a petition, pursuant to section 10 of the Act, requesting that, with respect to its ETC applications, the Commission forbear from applying the section 214(e)(1)(A) requirement that an ETC use at least some of its own facilities in offering services supported by the universal service support mechanisms.<sup>2</sup>

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, comments are due no later than **December 15, 2004** and reply comments are due no later than **December 29, 2004**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>3</sup>

Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/cgb/ecfs/>. Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of this proceeding, however, commenters must transmit one electronic copy of the comments to each docket or rulemaking number referenced in the caption. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send an e-mail to [ecfs@fcc.gov](mailto:ecfs@fcc.gov), and should include the following words in the body of the message, "get form." A sample form and directions will be sent in reply. Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, commenters must submit two additional copies for each additional docket or rulemaking number.
