FORFEITURE ORDER

Adopted: December 20, 2004 Released: December 22, 2004

By the Assistant Chief, Enforcement Bureau:

- In this Forfeiture Order ("Order"), we issue a monetary forfeiture in the amount of three thousand dollars (\$3,000) to Shadavrus Capital Trust, Inc. ("Shadavrus"), owner of antenna structure 1027884 in Lecanto, Florida, for willful and repeated violation of Section 17.57 of the Commission's Rules ("Rules"). The noted violation involves failure by Shadavrus to notify immediately the Commission upon a change in ownership information.
- On October 7, 2004, the District Director of the Commission's Tampa Office of the Enforcement Bureau ("Tampa Office") issued a *Notice of Apparent Liability for Forfeiture* ("NAL") in the amount of \$3,000 to Shadavrus.² Shadavrus has not filed a response to the *NAL*. Based on the information before us, we affirm the forfeiture.
- ACCORDINGLY, IT IS ORDERED that, pursuant to Section 503(b) of the 3. Communications Act of 1934, as amended ("Act"), and Sections 0.111, 0.311 and 1.80(f)(4) of the Commission's Rules, ⁴ Shadavrus Capital Trust, Inc. IS LIABLE FOR A MONETARY FORFEITURE in the amount of \$3,000 for willfully and repeatedly violating Section 17.57 of the Rules.
- Payment of the forfeiture shall be made in the manner provided for in Section 1.80 of the Rules within 30 days of the release of this *Order*. If the forfeiture is not paid within the period specified, the case may be referred to the Department of Justice for collection pursuant to Section 504(a) of the Act. Payment by check or money order may be mailed to Forfeiture Collection Section, Finance Branch, Federal Communications Commission, P.O. Box 73482, Chicago, Illinois 60673-7482.
