## **PUBLIC DEMONSTRATION AND TRAINING OF REDESIGNED UNIVERSAL LICENSING SYSTEM APPLICATION SEARCH INTERFACE WILL TAKE PLACE ON MAY 4, 2005**

As part of a continuing effort to improve the license application process, the Wireless Telecommunications Bureau (WTB) announces the completion of the redesign of the Application Search interface. WTB will hold a public demonstration and training of the new interface on Wednesday, May 4, 2005, from 10:00 a.m. to 12 noon. The event will take place in the South Conference Room (Room 8-B516), on the Eighth Floor of the Portals II building, at the Washington, DC headquarters, 445 Twelfth Street, SW. WTB requires interested parties to pre-register for the event by April 29, 2005.

### **New Application Search Environment**

The new design of Application Search will resemble the Universal Licensing System's (ULS) License Search. The new Application Search in ULS provides enhanced system performance, added search criteria, increased accessibility in accordance with Section 508 of the Rehabilitation Act, as amended,<sup>1</sup> and compatibility with most major Web browsers and operating systems. The visual redesign also offers greater convenience of use. In addition to the redesign of Application Search, new search capabilities in ULS License Search will be presented. The demonstration will include the following:

- Core functionality of the new search interface, including searches, search results, and search details;
- Basic search by file number, call sign, FCC Registration Number (FRN), and applicant name;
- Advanced search by application status, application purpose, radio service code, applicant information, and more;
- Service specific search for certain services;
- Specialized search by customized criteria within all relevant services;
- Search results with links to individual application information; and
- New features in License Search, including search capabilities and search details for construction buildout deadline search and site-based search.
